## Gulf & Pacific Equities Corp. reports on First Quarter Results with Revenue of \$924,915

**Toronto, May 27, 2015** – Gulf & Pacific Equities Corp. (TSX-V: **GUF**) an established company focused on the acquisition, management and development of anchored shopping centres in Western Canada, reports a 4.8% increase in revenues to \$924,915 in the first quarter of 2015 from \$882,765 at year end 2014.
